The new fraternal year is underway. Some big changes have happened in our country and require us to double down. The overturning of Roe vs Wade has sparked action on both sides. Many states are working to outlaw abortion, while others are setting it in stone within state constitutions. Many mainstream and other vocal people claim we are nothing but pro-birthers. We, as pro-lifers, know life is sacred and is to be protected from conception until natural death. This brings us to our newest program within the Knights: Aid and Support After Pregnancy (ASAP). For every \$500 we spend towards pregnancy resource centers or maternity homes (up to \$2,000), the Supreme Council will donate \$100. So, \$2,000 turns into \$2,400 towards these resources. On the Church front, we are undergoing not only the process of being one Parish Family, but also a Eucharistic Revival. Only 1/3 of Catholics believe in the true presence of Christ in the Eucharist. Through Substantiation, Jesus Christ is fully present Body, Blood, Soul, and Divinity. We are encouraged to deepen our devotion in the Eucharist. This past June, we participated in a Eucharist Procession on the Feast of Corpus Christi and expect this to be something we do with our Parish on a yearly basis. As well, our Parish's Youth promote Quarterly Eucharistic Adoration XLT. The next XLT Adoration is on October 2nd from 7pm-8:30pm.

On the topic of the True Presence of Christ, this is a reminder that we should never be receiving the Eucharist in a state of Mortal Sin. I encourage everyone to participate in the Sacrament of Reconciliation at least monthly. Our Reconciliation times are Tuesday, Noon-1pm and Saturdays, 11am-Noon. Reconciliation is also available by appointment (937) 433-1013 ext. 1001. You can use <u>masstimes.org</u> to find Confession any day of the week at nearby Parishes.

Lastly, do not forget about our Insurance Program. If you haven't talked to our agent, reach out to him and schedule a consultation. They can provide a Benefit Needs Analysis and help determine what you may still need. As well, if you have policies within the Knights, ensure all information and beneficiaries are up to date.
