Council 14504 Minutes for September 12th, 2023

Call to Order:

The meeting was held in person. The Grand Knight, John Hoffman, called the Council to order at 7:30 pm and led the Opening Prayer and Pledge of Allegiance.

Approval of Meeting Minutes

Council meeting minutes from August, 2023 were previously e-mailed to all members. After motions by Danny Sprouse and Sean Gammon, the Council approved the minutes as published.

Chaplain's Message:

Nothing reported.

Grand Knight's Report:

The Grand Knight shared that member of K of C Council 630 prayed for the 166 members who went to serve during World War 2 and that all members returned home safely.

All were advised that the Coats for Kids goal set by Supreme would involve the purchase of 6 cases of coats. A motion will be invited for the purchase of 4 cases of youth size coats and 2 cases of teen size coats at the cost of \$1598.

It was announced that the Knights at Holy Family are planning a Rosary Rally and that a \$100 contribution is suggested.

The Walk to End Alzheimer's will be held at Day Air Field on September 30th.

A recruitment table will be scheduled for the first weekend of October along with a CUF following the 4:30 PM mass on the next weekend.

Financial Report:

The Treasurer, Joe Schmidt, reported that there were deposits totaling \$573.19 and expenses of \$1927.87. The checking balance is now at \$6488.53. The savings balance is \$15,536.71.

Membership Report:

Transfer applications from William Paton and Stuart Harvey were reported. Cal Frank and Michael Tortorici motioned in favor of the application for Harvey. Steve Berns and Don Hirst motioned in favor of the application for William Paton. The council voted to accept both applications.

Program Reports:

Mike Manzo reported that the next spaghetti dinner will be after the 4:30 PM mass on September 30th and that there will be a Men's Club fish fry on November 17th.

Michael Tortorici provided information on the Pilgrimage trip being planned for July, 2024.

Michael Friel advised that a 4th degree exemplification is being planned for November 18 at St. Francis.
